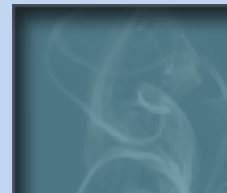

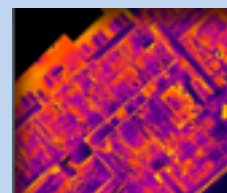
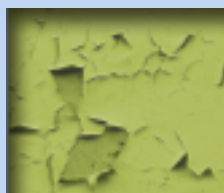


Asbestos sampling

Drone Aerial Inspections (IR)

- Safely inspecting structures such as roofs, towers, solar panels and more, with a drone mounted with a thermal camera

- Searching for moisture between exterior sheathing and interior foam board components to prevent mold, termites, and rot

Solar Panel Inspections

- Using thermal imaging and drones to find defective or malfunctioning solar panels that heat due to connection problems, physical damage, or debris
